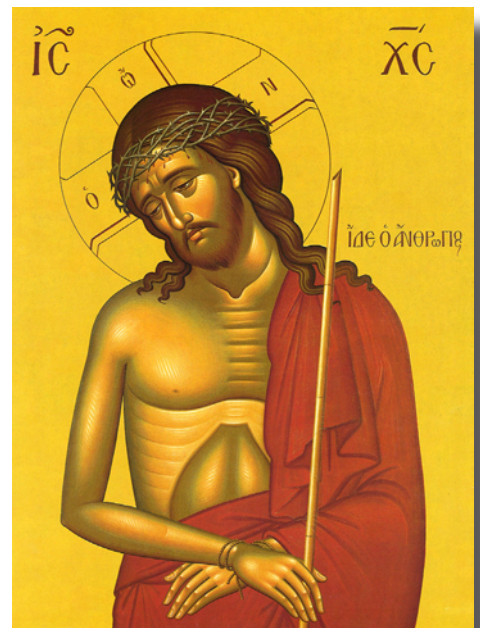

BIENNIAL NSP ELECTIONS

It is that time of year, when we once again start to think about the coming summer and our much anticipated trip to Nashville for Clergy-Laity 2006.

Although there will be much country music to enjoy, we as a National Board hope you will come prepared, and willing to get involved in all the NSP has to offer. As with each Clergy-Laity it will be time for us to elect our Executive Board, as well as Board members for those Metropolises who have not done so before coming to Clergy-Laity.

At the last Clergy-Laity in NYC, changes to the constitution were made regarding how elections will be handled and what the qualifications are for each office. I am taking this opportunity to explain these changes so that when we gather in Nashville we can be better educated as to these latest changes.

First let's talk about the nominating committee:

Article 2, Section 4: states...

The nominating committee shall consist of three members. The immediate Past President shall serve as chairman with two additional members. The Presbyteres attending the NSP conference shall elect the additional two members. In the event of a vacancy on the nominating committee, the executive board shall choose the replacement. Members of the Nominating Committee are not eligible to stand for election to the five executive offices.

The Nominating Committee shall accept nominations and present the names of all qualified nominees to the body of Presbyteres present at the NSP Conference held at the Archdiocesan Clergy-Laity Congress. Nominations for each office shall be taken from the floor at the first business meeting at the Clergy-Laity Congress.

Now we shall move on to the responsibilities and qualifications of the each of the NSP Executive Offices:

Article 2, Section 5: states...

The President:

The President shall be elected to a two-year term and may serve a maximum of two consecutive terms. The nominee for President shall have served at least one two-year term on the NSP National Board.

The President shall be responsible for convening at least one annual meeting of the NSP Board. The President, after each Archdiocesan Clergy-Laity Congress, shall submit the names of the members of the new NSP Board to the Archbishop and to the Hierarch of each Metropolis. The President shall be one of the four administrators of the APC (Archdiocesan Presbyters Council) and the NSP Benevolent Fund, and, along with the APC President, is responsible for generating the annual appeal letter.

The President shall be a member of each standing committee and is responsible for conferring with the committee chairmen of the various NSP projects. The President shall represent the NSP at Archdiocesan functions whenever possible. If she cannot attend, she shall ask the Vice-President or another representative to attend.

The President shall be an ex-officio member of the Archdiocese Benefits

Committee and if appointed by the Archbishop, shall be a member of the Archdiocesan Council and National Philoptochos Board. The President shall oversee that the Constitution is adhered to in all matters concerning the NSP.

The Vice-President:

The Vice-President shall be elected to a two-year term and may serve a maximum of two consecutive terms. The nominee for Vice-President shall have served at least one two-year term on the NSP National Board.

The Vice-President shall be one of the four administrators of the APC and NSP Benevolent Fund. If so deemed by the four administrators, she shall be responsible for handling the Benevolent Fund Emergency and Reserve Accounts. The Vice-President implements the annual Benevolent Fund appeal and acknowledges each contributor. The Vice-President must submit a report of income and expenditures of the APC and NSP Benevolent Fund at each NSP Board and Sisterhood general meeting.

The Vice-President may represent the President at any meeting or other function that the President cannot attend. In the event the President is unable to complete her term, the Vice-President shall serve out the remainder of the President's term.

Recording Secretary

The Recording Secretary shall be elected to a two-year term and may serve a maximum of two consecutive terms.

The Recording Secretary shall be responsible for keeping the minutes of all NSP Board and NSP Conference Meetings. The Recording Secretary shall be responsible for keeping the NSP mailing list current.

Corresponding Secretary

The Corresponding Secretary shall be elected to a two-year term and may serve a maximum of two consecutive terms.

The Corresponding Secretary shall be responsible for all NSP correspondence and the NSP Newsletter. The Corresponding Secretary shall be responsible for sending sympathy cards on behalf of the NSP to the family of a deceased family member.

The Treasurer

The Treasurer shall be elected to a two-year term and may serve a maximum of two consecutive terms.

The Treasurer shall be responsible for maintaining the NSP financial account(s). The Treasurer shall be chairman of the NSP Stewardship and shall maintain a record of donations.

The Treasurer shall submit a report of income and expenditures at each NSP Board Meeting and NSP Conference. The Treasurer shall be responsible for sending a donation in memory of a recently deceased Priest or Presvytera to the APC/NSP Benevolent Fund.

NOW...what does all this mean?

Well, the National Board would like for us all to keep in mind, on the first business meeting names will be taken from the general body for nominations to each executive office. Nominations will be closed after nominations have been taken, and on the designated day the nomination committee will provide a ballot of all eligible candidates to the body of the NSP to be voted upon.

Metropolis of San Francisco

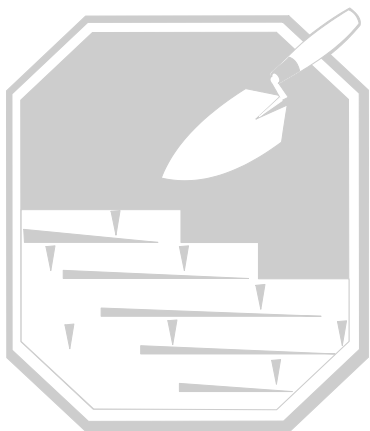

Prayer is certainly the cornerstone of a Christian's life experience. Pray at regular times during the day, include mealtimes, the start of a trip, blessing the children before leaving home for school.
